

## Post Summer Feedback Survey & Competition Survey Prize Draw Terms & Conditions

1. The Fulham Stadium Limited prize draw (the “Prize Draw”) is operated by Fulham Stadium Limited (“Fulham”), whose registered office is at Motspur Park, New Malden, Surrey KT3 6PT.
2. The survey and Prize Draw is open to residents of Great Britain aged 18 years old or over. Employees, officers, directors, agents and representatives of Fulham and each of their respective affiliates and subsidiaries (the “Released Parties”) as well as any immediate family member of an employee of a Released Party, are not eligible to participate in the Prize Draw or win any prizes under it. The Prize Draw is void to any entrants outside of Great Britain within the terms described above, and where such entry is prohibited by law.
3. By completing the entry survey you will automatically be entered into a free prize draw, entrants agree to be bound by the rules contained herein (the “Official Rules”) and the decisions of Fulham, which will be final and binding on any participants in the Prize Draw.
4. The winner of the Prize Draw will be selected at random. No purchase is necessary and no entry fee is required to participate in the Prize Draw. The winners of the Prize Draw will win the following prize:

6. All entries in the Prize Draw become the property of Club and will not be acknowledged by Fulham. To participate in the Prize Draw during the Prize Draw Period, each entrant must complete the Post Summer Feedback Survey & Competition and such completed survey must be received by Fulham by Wednesday 23 September, 11.59pm (the “Closing Date”). Any entries received after the Closing Date will be void.
7. Only one (1) entry, using one (1) email address, per person, will be allowed to enter the Prize Draw. Any entrant who is deemed by Fulham to have attempted to enter more than one (1) entry will be disqualified from the Prize Draw and ineligible to win any prize under it. In the event that the winner of any prize under the Prize Draw is discovered by Fulham to have submitted more than one (1) entry or has otherwise breached the Official Rules (and/or Fulham has reasonable grounds to believe either of the same) Fulham reserves the right at its absolute discretion to disqualify such person from the Prize Draw and select an alternative winner.
8. For the avoidance of doubt, the use of script, macro or automated devices (or any other devices intended or used to automate or subvert any aspect of entry) to enter the Prize Draw is prohibited and any entry through such means will result in disqualification. In the event of any dispute regarding entries received from multiple users having the same e-mail account, the prize will be awarded to the person named on the registration form on the winning entry. Photo identification may be required.

Released Parties are not responsible for, and by entering the Prize Draw entrants shall be deemed to have waived and released the Released Parties from, any claims or complaints arising out of or in connection with late, lost, stolen, incomplete, misdirected, delayed, illegible, inaccurate, or undelivered registration forms or entries, or for telephonic, human, electronic or computer failures, problems or errors, interruptions in service due to system upgrades, repairs, modifications or other causes, failures or malfunctions of connections, electronics, satellite, network, cable, Internet Service Provider (ISP), phones, mobile, or other devices (including wireless phones/handsets or other wireless devices), phone lines or

telephone systems, traffic congestion on the internet, technical or mechanical malfunctions, or other malfunctions or errors, whether caused by equipment, programming, human error or otherwise relating to or in connection with the Prize Draw, including, without limitation, errors which may occur in connection with the administration of the Prize Draw, the processing of registration forms, entries or the announcement of the prize, the cancellation or postponement of any game, or for any injury or damage to entrant's or any other person's computer or wireless device relating to or resulting from participation in this Prize Draw, or for printing, typographical, human or other errors appearing in these Official Rules or other Promotion-related materials. Entrants are responsible for any charges of online service providers or wireless carriers. Fulham reserves the right, in its sole discretion, to void any entries of entrants whom Fulham believes have attempted to tamper with or impair the administration, security, fairness or proper play of this Prize Draw or is in violation of these Official Rules.

All personal information submitted by entrants will only be used in accordance with any applicable laws and Fulham's Privacy Policy, a copy of which can be found [here](#), but for the avoidance of doubt, unless expressly consent is received otherwise, the entrant data will be used for the purpose of administering the Prize Draw only. The prize winners may be asked to participate in a promotional activity instigated by Fulham relating to the Prize Draw, however any participation shall be subject to each individual prize winner providing their consent.
11. Fulham shall select one (1) winners from eligible entries to the Prize Draw in a random draw conducted on or after Wednesday 23 September, 11.59pm as determined by Fulham. The prize winners will be contacted by Fulham and must respond to the notification within 2 days of the notification being delivered. If Fulham is unable to contact any potential prize winner or the prize winner is not in compliance with these Official Rules, the prize will be forfeited and Fulham shall, at its absolute discretion, be entitled to select an alternate winner from a further random draw of any remaining eligible entries.
12. No transfer, assignment, cash redemption, or substitution of the prize (or any part or portion thereof) is permitted by or on behalf of any entrant. Where the prize is unavailable in full or in part, Fulham reserves the right to substitute the prize for another prize of comparable or greater value, at its absolute discretion. In this event, Fulham shall have no liability to the prize winner or any other entrant arising out of or in connection with the substitution of the prize. Where Fulham cannot contact the chosen winner, Fulham shall make the prize available to another entrant and shall have no liability to the first prize-winning entrant.
13. The Released Parties shall have no liability and will not be held responsible for any claim, action, liability, loss, injury or damage, including, without limitation, personal injury or death or damage to personal or real property, due in whole or in part, directly or indirectly, by reason of the acceptance, possession, use or misuse of a prize and any travel or travel-related activity thereto or participation in this Competition, except in respect of death or personal injury to an entrant caused by the negligence of Fulham or to the extent that any such liability cannot be excluded or limited by law.
14. Fulham reserves the right, in its sole discretion and without liability to any entrant, to modify, suspend, and/or terminate this Competition for any reason, including should viruses, bugs, non-authorized human intervention or other causes corrupt or impair the administration, security, fairness or proper play of the Competition and, in the case of termination, at its discretion, select the potential winner from among all eligible non-suspect entries received prior to the event that required such termination.
15. The Competition, these Official Rules and the rights and obligations of any entrants shall be governed by, and construed in accordance with, the laws of England and Wales. Any and all disputes and causes of action arising out of or connected with this Promotion, or any prize awarded, shall be subject to the exclusive jurisdiction of the courts of England and Wales.
